PUBLIC HEARINGS:

- 1. Amendment No. 1 to Conditional Use Permit No. 99-03:** request to amend Conditional Use Permit No. 99-03 to: a) allow the installation of an additional staff residence; and b) to increase the maximum number of residents from 90 to 125, at the existing Teen Challenge facility located in the Community Facilities (CF) District. The project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15061 (b)3 of the CEQA Guidelines.
- 2. General Plan Amendment No. 13-23; Zone Change No. 13-56:** a minor amendment to the City of Shafter General Plan on 10 acres of land within the City of Shafter. The project would change the land use designation from BP (Business Park) to I (Industrial) and the zoning from BP-H (Business Park – Airport Approach Height Overlay) to I-H (Industrial – Airport Height Overlay). An addendum to the Certified Final Environmental Impact Report for the 2005 General Plan Update has been prepared for the project.
