from 6,013 square feet to 13,670 square feet. The project site is located at the northwest corner of Seventh Standard Road and Calloway Drive in Shafter.

2. **TENTATIVE TRACT NO. 6773:** a proposal to subdivide approximately 20 acres (12 acres net) into 76 single-family residential lots within the 957 acre Coberly West Specific Plan. The proposed lot sizes range from 6,201 square feet to 9,782 square feet. The project site is located at the northeast corner of Seventh Standard Road and Verdugo Road in Shafter.
