**DEPOSITS AND FEES**

The following fees are to be collected by the City for each construction hydrant issued:

- \$1,000 Advance Security Deposit to be used toward repairing or replacing a meter
  - Refundable within four to six weeks after meter is returned to and inspected by the City.
  - Cost to repair or replace the meter not covered by the security deposit will be the responsibility of the applicant.
- \$60 Initial Set-up Fee. **(billed in the first monthly statement)**
- \$60 Disconnection Fee. **(billed in the last monthly statement)**
- \$483.67 as the fixed monthly water service fee is to be billed plus a standard usage rate of \$.86 per 1,000 gallons and a supplemental usage rate surcharge of \$1.06 per 1,000 gallons for select areas of the City or as adopted by the City Council.

CONDITIONS AND PERMIT PROVISIONS:	INITIAL
1. Fire Hydrant Meters are to be connected to a water source designated by the City and secured at all times by the applicant.	
2. Water shall not be used for: <ul style="list-style-type: none"> <li>a. Drinking or domestic purposes.</li> <li>b. Agricultural purposes.</li> <li>c. To fill pools, lakes or ponds.</li> </ul>	
3. Any damages or other issues with a meter are to be reported to the City immediately for possible repair or replacement.	
4. Applicant must comply with requirements of all City of Shafter Ordinances and policies.	
5. The City reserves the right to cancel/terminate temporary water service at any time without notice.
